The Town Council, on May 16, 2023, completed the final interviews with the Town Manager candidates. The consulting firm of Randi Frank Consulting, LLC has been assisting in the tentative Employment Contract negotiations, as authorized on May 23, 2023.

This action will require no less than six (6) affirmative votes of all members present and voting.
